Meeting Notes from the Tuesday, September 5, 2017 Meeting

The Town Board's Finance and Administrative Services Committee (the FASC) met at 3:30 p.m. and reviewed a number of contractual, procurement, finance and/or budget, and personnel related matters referred by Town departments and is prepared to make recommendations to the full Town Board as follows:

Contract with Rochester-Monroe County Youth Bureau (Rec. Appropriate Seized Funds for Camera (Police Dept.) – The FASC discussed with Chief Mark Henderson his request for Town Board action to appropriate \$4,999 from seized funds for the purchase of an L-Tron 360 Degree camera and related equipment and software.
The FASC recommends the Town Board take favorable action on this matter.

Declare Vehicle as Surplus for Auction – The FASC discussed with Suzanne Zaso her request for Town Board action to declare a 2003 Chevy Impala as surplus and authorize disposal through auction. The vehicle was originally purchased by the Police Dept. and then transferred to the Recreation Dept. when it was no longer usable for police work. It currently has over 119,000 miles. The FASC recommends the Town Board take favorable action on this matter.

Declare Loader as Surplus for Auction (Highway) – The FASC discussed with Mike Guyon the request from Tim Anderson for Town Board action to declare a 2000 Case Loader as surplus and authorize disposal through auction. The department recently purchased a new loader. The FASC recommends the Town Board take favorable action on this matter.
