**OLD BUSINESS**

1AR-2-22 Revised— 830 Highland Ave — New single-family home

Notes: \* Plans, drawings, and photos were presented by Jarrad Coon, architect for the applicant, for review by the board

- No downspouts. Roof drains to rear center (corner of patio) to internal drainage.
- Concerns about potential for tinted or mirrored glass. Jarrad Coon: windows not spec'd at this time but will need to deal with solar gain. Attested they will not have a mirrored finish.
- Second level windows: expanse will be divided into four main sections by vertical structural dividers. Each of the four sections, in turn, will have three equally sized panels of glass in each.
- Mechanical equipment will be interior (first level mechanical room) or on north side of building.
- Clarify whether and what type of door at pedestrian entrance at SW corner of building (floor plans and renderings conflict). The owner said it may be a roller door and they would try to have the style consistent with the garage doors.
- Exterior material changed on mass section to smooth ACM – will be proud of the concrete.
- Roof sections and stair cover details provided.
- Wood trellis outside glazing.
- Garage door windows to be frosted glass.

Decision: **Approved with conditions**

- **Provide detail on pedestrian entrance door at SW corner. Door will be coordinated with the design of the garage doors as discussed at the meeting.**
- **Garage door windows to be frosted glass as discussed.**
- **No mirrored glass on second level.**

## NEW BUSINESS

2AR-1-22— 65 Brookside Dr — GreenSpark — Roof Mounted Solar

Notes: \* Plans, drawings, and photos were presented by Sean Mullen, contractor for the applicant, for review by the board

- Pattern of panels on east (front) façade. Missing panels are due to existing roof penetrations. Sean Mullen: Alternative patterns were explored; the pattern presented is most efficient for energy production.
- Conduit mostly routed internally except for exposure behind the house.

Decision: **Tabled**

- **Resolve panel arrangement on east façade to increase symmetry and reduce ‘holes’ in array**
  - **Explore installation of “dummy” panels to fill gaps if necessary**
  - **Provide front elevation with existing roof color**

---

2AR-2-22— 2715 W. Henrietta Rd— Alliance Fleet — Enclosing area under a building overhang

Notes: \* Applicant not present

Decision: **Tabled for lack of representation**

---

2AR-3-22— 90 Bradford Rd — 3<sup>rd</sup> Rock Solar — Roof Mounted Solar

Notes: \* Plans, drawings, and photos were presented by Steve Reed, contractor for the applicant, for review by the board

- Layout of panels is erratic
- Vertical and horizontal layout on same roof plane is awkward
- Conduit is substantially visible

Decision: **Tabled**

- **Resolve design problem**
  - **Reduce exposed conduit runs on top of roof**
  - **Rearrange panels for a more cohesive layout**
